In the event in-person classes are suspended by the WCPSS through the end of the 2023 Spring semester, refund of parking fees will be prorated according to the number of full academic months remaining to the end of the Spring semester. The refund will be \$20 per remaining academic month for non-members and \$15 per remaining academic month for members.

	This agreement is made this ____ day of _____, 2022, between the Cary Swim Club, Inc. (hereinafter, 'CSC') and the undersigned Cary High School student and his/her parent(s) or guardian(s) (hereinafter collectively, 'Student').										
1	CSC and Student agree for Student to park a registered vehicle in the CSC parking lot, in the assigned space, located at 808 Tanglewood Drive, Cary, North Carolina, during the Fall Semester, 2022 and the Spring Semester, 2023. CSC shall provide Student with a permit (hereinafter, the 'Permit') which shall be displayed on the vehicle while parked in CSC's parking lot.										
2	<i>LOCK YOUR VEHICLE - DO NOT LEAVE VALUABLES OR ELECTRONICS IN A VISIBLE PLACE IN YOUR VEHICLE</i> The undersigned acknowledges that CSC shall not be liable for any injuries to Student or any Passengers, or any damages, thefts, or claims associated with parking a vehicle on CSC's property.										
3	CSC may contract with a towing service to enforce proper parking in the parking lot. A valid parking Permit MUST BE CLEARLY DISPLAYED through the windshield of a vehicle and parked in the ASSIGNED space only. All other vehicles found parking in that space will be TOWED. The towing service works independently of the Cary Swim Club and will enforce properly registered parking. CSC shall not be liable for any automobile damage, errors, or inconvenience caused by the Towing Service.										
4	All passengers or car-poolers (hereinafter, 'Passengers') will be held to the same code of conduct as the Student. Violations of this agreement by any Passengers may result in termination of this Agreement by CSC.										
5	The Parking Lot will be open from 6:30 am until 6:00 PM, Monday through Friday. In order to insure safety and to protect your cars and CSC property, the lot MAY BE LOCKED at all other times.										
6	The Parking Lot MAY BE CLOSED in the event of ice, snow or sleet or other events which delay or prevent the opening of school. Students will be notified when the lot reopens.										
7	In the event a Student or Passenger is found <u>LOITERING, LITTERING, SMOKING, vandalizing or defacing pool, private, or public property, including driving on or across any grassy or planting areas on CSC premises,</u> the Student will lose the right to park on CSC property and this contract will be terminated. Student and Parent shall be responsible for any damage to CSC property caused by Student. Only registered students and their passengers will be allowed on CSC property during the posted hours. All others will be subject to trespassing charges.										
8	<i>Transfer of the Permit is allowed only to registered vehicles. Any changes of ownership of the Permit and any additions of vehicles must be approved in advance and in writing by CSC. Transfer Fee of \$25.00 is due at the time of transfer. Failure to properly register vehicles may lead to the towing of a vehicle and revocation of the parking permit</i>										
9	The CSC Board of Directors and its designees will have final decision to determine whether a Permit should be terminated due to violation of this agreement. If a Student's Permit is terminated, reimbursement will be prorated according to the time remaining to the end of the Spring semester less an administrative fee of \$25										
10	If the privilege to park on CSC property is abused, including littering, driving on grassy areas and/or if students do not respect the property of the Swim Club, or do not adhere to the guidelines for parking, CSC may immediately revoke the right to park to any and all individuals, whether or not Student is personally responsible for failing to adhere to such guidelines.
